For patients

Patients can submit a co-pay claim for reimbursement by mail or by faxing a completed <u>claim form</u> with the appropriate supporting documentation to **1-908-548-9364**.



For specialty pharmacy

A specialty pharmacy (SP) co-pay-only portal allows pharmacies to complete enrollment, submit claims, and track program activity. To access our SP portal, visit **LEQVIO-CopayPortal.com**.
